Result 1: Improved coordination among key regional, national and local level stakeholders in DRR, public awareness raising, advocacy and learning.

- District Disaster Management Committee (DDMC)- focus on local response, early warning, vulnerability mapping, monitoring, district level coordination for DRR
- Watershed Council comprises members from all affected sucos and focuses on analysing cause and effect and the planning and implementation of mitigation measures appropriate to the watershed
- CBDRM working group focus on practice and learning from the implementation of community based disaster risk management in Timor-Leste
- National Disaster Management Directorate (NDMD) under the Ministry of Social Solidarity, the directorate focuses on disaster operations, national response, compiling monitoring data, implementing the national disaster management policy.

Disaster Risk Management Institutional & Operational Systems Development in Timor-Leste

Timor-Leste

Dili; Bobonaro and Lautem Districts.

October 2008 - September 2009 Disaster preparedness & prevention; Institutional strengthening

Result 1: National Disaster Operations Centre (NDOC) strengthened and two new District Disaster Operations Centres (DDOC) established in Bobonaro and Lautem along with necessary operational systems and mechanisms.

Activities 1:

- 1.1. Map stakeholders and partners both in government and civil society to identify information, coordination and communication gaps and define possible shortcomings in the chain-of-command as identified by rules and regulations both at national and sub-national levels
- 1.2. Assess capacity for Disaster Risk Reduction & Management (DRRM) both in Government and civil society to identify strengths, weakness/needs, opportunities, and threats
- 1.3. Based on the assessment results, develop and implement a capacity development plan to strengthen human resources and systems for better information flow, communication and coordination on DRRM
- 1.4. Undertake procurement of necessary hardware/ software systems for NDOC and DDOCs for data collection and analysis, and early warning
- 1.5. Organize consultation meetings with various stakeholders to collect baseline information, and to eventually discuss and validate different proposals or scenarios identified following desk studies
- 1.6. Develop Standard operation procedures (SOP) for priority national hazards and corresponding guidelines on communication, information management and coordination
- 1.7. Undertake training on SOPs for stakeholders in participating districts Capacity development and on-the-job mentoring of NDOC and DDOCs staff to undertake multihazard, and vulnerability risk analyses.

Result 2: Communication channels are well established between communities, DDOCs, NDOC, and other line government entities for efficient early warning, contingency planning and response.

Activities 2:

- 2.1. Organise a national workshop to review and discuss existing and planned institutional DRM machinery, including roles, responsibilities, challenges and linkages among different actors
- 2.2. Assist the Government in developing basic guidelines and codes of practice for information management, communication and coordination
- 2.3. Organise simulation exercises to test and refine coordination mechanisms and procedures Identify linkages with regional international organisations for future cooperation on early warning and DRRM, particularly with neighbouring countries.

Result 3: Awareness raised on DRM amongst partners including *Chefes de Sucos*, District Administrations, line ministries, civil society, and media, and DRM mainstreamed in Government planning.

Activities 3:

- 3.1. Organise training on DRRM as a cross-cutting issue in participating districts and develop in consultation with partners a relevant training module for newly elected/ appointed District Administrators & *Chefes de Sucos*.
- 3.2. Organize a workshop for lead ministries to discuss mainstreaming DRRM in government planning
- 3.3. Implement a national information campaign to socialize DRM procedures, information points, communication procedures, & coordination mechanisms for more active engagement of the public in the national DRM system.
- 3.4. Assist NDMD in undertaking its financial planning and drawing its 2009 budget for DRRM. Develop and deliver a training module on DRM to journalists/ reporters for a wider socialization of DRM issues in collaboration with the on-going UNDP Media Project.
