## Guidebook on Advocacy: Integrating CBDRM into Government Policy and Programming

This “Guidebook on Advocacy for Integrating CBDRM into Local Government Policy and Programming” aims to develop and strengthen the skills and knowledge of stakeholders on designing and implementing advocacy strategies to integrate Community-Based Disaster Risk Management (CBDRM) into policy-making, planning and programming of local authorities in Southeast Asian countries. It draws heavily on the inputs and participation of CBDRM practitioners who attended the “Regional Workshop on Advocacy for Integrating CBDRM into Planning and Programming of Local Authorities” held in Bangkok, Thailand on 18-21 April 2006. The workshop was organized by ADPC / PDRSEA 3 in cooperation with UNESCAP and funded by DIPECHO.

## Community-Based Disaster Risk Management for Local Authorities (Participants’ Workbook)

The purpose of this workbook is to facilitate the capacity building of local government officials on Community-Based Disaster Risk Management (CBDRM) in Southeast Asian countries including Cambodia, Indonesia, Lao PDR, Timor L este and Vietnam. It is expected that the workbook will be adapted and used by National Disaster Management Offices (NDMO) and NGOs in the countries of South East Asia for training the local government officials. CBDRM practitioners who attended the “CBDRM Curriculum Development Workshop” on November 2005 in Bangkok, Thailand provided invaluable comments and suggestions to the original draft of this participant’s workbook. The workshop was organized by ADPC / PDRSEA 3 in cooperation with UNESCAP and funded by DIPECHO.

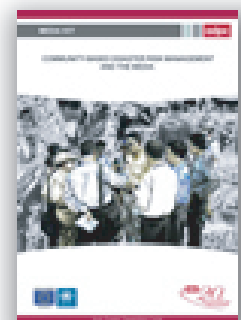


## Critical Guidelines on Community-Based Disaster Risk Management

The practice of community-based approaches has remained diverse due to a host of factors including the organizational mandates of concerned organizations, socio-cultural context of the communities, levels of economic development of communities, political structures in a country and multiplicity in funding cycles of donor organizations. This diversity has raised concerns about the quality in practice and the need for promoting good practices in CBDRM. This “Critical Guidelines on Community-Based Disaster Risk Management” responds to the demand within the disaster risk reduction community to formulate minimum standards for practice in the area of community-based disaster risk management. It was drafted through a consultative process with stakeholders and particularly as a result of the “Regional Workshop on Standards of Community Based Disaster Risk Management” held on 24-27 January 2006 in Bangkok Thailand. The workshop was organized by ADPC / PDRSEA 3 in cooperation with UNESCAP and funded by DIPECHO.

## Media Kit: Community-Based Disaster Risk Management and the Media

This Media Kit has been developed as a guide for media professionals in five Southeast Asian countries (Cambodia, Indonesia, Lao PDR, Timor L este and Vietnam) to raise the awareness of media professionals about its role in disaster risk reduction; and to enable them to perform that role in an effective manner. The Handbook is comprised of two parts. Part one explains the key concepts of disaster and media, CBDRM, the role of media in disaster risk management, and useful information for the media on disaster preparedness. Part two includes country-based resources such as hazard profiles, case studies on CBDRM, and contact information of national and regional organizations engaged in disaster risk management.



## Proceedings of the Fourth Disaster Management Practitioners’ Workshop for Southeast Asia

This document brings together the Proceedings and Outcomes of the “Fourth Disaster Management Practitioners’ Workshop for Southeast Asia” (DMP SEA) held on 8-10 March 2006 in Bangkok, Thailand. The main theme of the workshop was “Learning from Community Based Practices: Strengthening Policy and Partnerships”. It is hoped that this document will be a reference point for future initiatives in community-based disaster risk management. This is the fourth time practitioners in CBDRM gathered to discuss the status of CBDRM, issues and solutions for making communities more resilient to disaster impacts leading to poverty alleviation and sustainable development. It also presents papers on the different themes and country reports on CBDRM and outcomes of the group discussion. The three day workshop was attended by more than 70 participants from over 12 countries within and outside this region. The workshop was organized by ADPC / PDRSEA 3 in cooperation with UNESCAP and funded by DIPECHO.
