5. Lessons learnt/ Additional comments

- Given an extremely tight schedule to accomplish this project, it is uncovered that a well coordinated work plan formulation and implementation is very crucial to achieve expected outcomes within the designated timeline. Any unexpected change in agreed work plan/ activity schedule might have significant implications in overall management of activities to achieve desired final outcome.
- It is observed that the organizational mechanism of disaster management system is quite complicated especially to address earthquake issues. Inter-agency network among different organizations is not very strong that may hinder to address disaster management system comprehensively in the long run. To respond this kind of issues, the Sub-implementing Agencies need continuous guidance from CDMP.
